Please note the following.

- I. On the basis of the “**Interaction**” & Written held on 29th **March 2025 (Saturday)** for admission to Classes **Nursery to IX** the “**List of Students selected for admission**” has been uploaded.
- II. Admission to Classes **Nursery to V** shall start from **08th April 2025 (Tuesday)** and will close on **10th April 2025 (Thursday)** & admission to Classes **VI to IX** shall start from **10th April 2025 (Thursday)** and will close on **12th April 2025 (Saturday)**
- III. Parents must approach the “**School Counter**” between **9:00 am to 1:00 pm.**
- IV. The following **documents/items** shall be required at the time of admission.
 - Two recent **passport size photographs** of the student
 - One **photograph** of the student along with his/her **Father and Mother**
 - “**Date of Birth**” certificate issued by the “**Municipal Corporation**” or the local “**Block Office**”
 - “**Proof of “Address”** of the **Parents (Father and Mother)**
 - Photocopy of the “**Aadhaar Card**” of the student
 - “**Medical Fitness Certificate**” issued by a registered “**Medical Practitioner**” it also includes blood group , height & weight of your child.
 - **PEN (Permanent Education Number)/APAAR ID Card** for admission to **Class II** and above.
 - **TC issued by the previous School / last class passes for STD-III and above.**
 - “**Affidavit**” issued by a “**First Class Magistrate**” stating that no request for changing any of the information provided to the school shall be put forward in the entire tenure of the student in the school (Sample format of the “**Affidavit**” has been uploaded)
- V. The total **Fee** to be paid at the time of admission are as follows
 - **Nursery, LKG and UKG – Rs 13850/-**
 - **Classes I to V – Rs 14350/- Classes VI to VIII – Rs 15150/- Class – IX – Rs 16300/-**
The above mentioned amount includes the **Fee** for the month of **April 2025**
NOTE : Payment will be accepted through Debit / Credit card or UPI only.
- VI. The “**Monthly Fee**” in the “**Academic Session 2025 – 26**” shall be as follows
 - **Nursery, LKG and UKG – Rs 1700/-**
 - **Classes I to V – Rs 2200/- Classes VI to VIII – Rs 3000/- Class – IX – 3500/-**
- VII. “**Set of Textbooks**” shall be provided by the school The cost of the same shall be charged **extra.**

VIII. Parents opting “**Transport Facility**” shall be required to fill up the requisite form, submit the same and collect the “**Transport Card**” after completing the formalities of admission. The **Transport Fee** shall be charged extra and will be as follows.
